SENIOR FUND

The Lockport Township Board of Trustees met in the Central Square Board Room 318, 222 East Ninth Street, Lockport, Illinois on Monday April 11, 2016 at 7:11 PM with Supervisor Ron Alberico presided.

Present were Trustees, John Batusich, Barb Boyce, Mike Lewandowski and Dean Morelli, Clerk Denise Mushro Rumchak, Assessor Debbi Mason, Highway Commissioner John Cielenski, Collector Lance McCalla, Deputy Clerk Michele Rutter and Attorney Gary Mueller and Jessica Strickland. Also present were residents, Miriam Salvador, Sue Bebrich, Carl Bebrich, Jose Barrios, Darren Deskin, Grant Spooner, filming the meeting and Gina Gramarosso with the Northern Illinois Food Bank. The meeting notice and agenda were posted at the Lockport & Crest Hill Libraries, the Joliet Herald News, at the Central Square Building, the Lockport Township website (Clerk's section) and also on the Board Room door.

On a Motion of Batusich, seconded by Boyce to approve the minutes from the previous monthly meeting as presented for the March 14, 2016 regular meeting.

Trustee Morelli inquired about the expenses for bus maintenance. Supervisor Alberico explained that the amount is from two buses that were towed and needed repair.

New Business- Gina Gramarosso addressed the Board regarding the Northern Illinois Food Bank. Gina discussed how the Township can get involved, and the future plans for a new building in the Summer of 2017. Gina thanked the Board for their time.

Supervisor Alberico will be handing out monthly reports for rider ships on the Senior Bus Service. There were 574 trips in the month of March. He states that the seniors are very happy with the bus service.

Supervisor Alberico handled out a Pace packet with options for replacing the existing buses with the possibility of renting from Pace on a monthly basis. The monthly fee is \$100.00 per bus. He encouraged the Board to look at the buses. Clerk Rumchak asked about the expense for insurance. Supervisor Alberico will look further into the matter. Trustee Batusich suggested a Workshop be scheduled. Supervisor Alberico will assemble a workshop, information to follow.

Supervisor Alberico announced the TRIAD Senior Health Expo is schedule for May 25, 2016 from 9:00am-12:00pm at the Edwards Hospital Athletic and Events Center in Romeoville. This expo is free to seniors.

Old Business- Supervisor Alberico attended the Joliet Junior College Expo that was held on March 16, 2016. He expressed the event was very successful.
