SENIOR FUND

The Lockport Township Board of Trustees met in the Central Square Board Room 318, 222 East Ninth Street, Lockport, Illinois on Monday May 9, 2016 at 7:25 PM with Supervisor Ron Alberico presided.

Present were Trustees, John Batusich, Barb Boyce, Mike Lewandowski and Dean Morelli, Clerk Denise Mushro Rumchak, Highway Commissioner John Cielenski, Collector Lance McCalla, Deputy Clerk Jessica Strickland and Grant Spooner filming the meeting. Absent were Debbi Mason and Attorney Gary Mueller. The meeting agenda was posted at the Lockport & Crest Hill Libraries, the Joliet Herald News, at the Central Square Building, the Lockport Township website (Clerk's section) and also on the Board Room door.

On a Motion of Batusich, seconded by Boyce to approve the minutes from the previous monthly meeting as presented for the April 11, 2016 regular meeting.

On a Motion of Boyce, seconded by Morelli, to approve the total bills and payroll for the Senior Fund in the amount of \$49,864.24. Roll call vote resulted in Alberico Aye, Batusich Aye, Boyce Aye, Lewandowski Aye and Morelli Aye.

Supervisor Alberico announced that the shingle shot program took place on Tuesday May 3, 2016. He expressed how happy he was with the amount of seniors that had showed up. There were 29 residents who received their vaccinations. He stated that there were 21 residents that are still on waiting list and the next schedule date on August 2, 2016 has already been filled with 29 residents. He suggested to the Board to schedule the program for one day out of the year and have every senior that applied vaccinated so individuals will not have to be put on a waiting list. Supervisor Alberico also commented that the Township funding will be the same amount for the year, so why make seniors wait. Clerk Rumchak expressed how much the seniors appreciate the program being available to them. Trustee Lewandowski asked if a discounted rate could be applied with a larger number of residents being vaccinated. Supervisor Alberico responded that the Township has received a discount rate for this program.

Supervisor Alberico mentioned that the application for the Pace buses has been filled out. All maintenance will be covered through Pace and the only cost to the Township will be rental cost and the fuel expense. The application process takes approximately three to four months until it is complete. Supervisor Alberico suggested setting up a meeting with a Pace representative for any questions or concerns while being able to view the vehicles.

Supervisor Alberico announced the TRIAD Senior Health Expo is schedule for May 25, 2016 from 9:00am-12:00pm at the Edwards Hospital Athletic and Events Center in Romeoville. All seniors are welcomed.

On a Motion of Batusich, seconded by Lewandowski to adjourn the meeting at 7:35 PM.
